Laws relating to the termination of pregnancy vary greatly from country to country, from absolute prohibition to depenalisation in some cases and in some countries with the circumstance of permission. Now sadly the variance seems to be the case in these supposedly United States. Newly drafted and passed states take direct aim at long-standing Supreme Court precedent.

The 1973 landmark ruling in *Roe v. Wade*, 410 U.S. 113 recognized that the right to abortion is fundamental liberty protected by the Fourteenth Amendment of the Constitution. Since *Roe*, the Court has repeatedly reaffirmed the Constitution's protection for this essential liberty, which guarantees each individual the right to make personal decisions about family and childbearing.

Conservative states around the country, like the most recent cases in Alabama and Mississippi, have moved a conservative state legislature to pass restrictive abortion laws aimed at giving the Trump appointed majority Supreme Court the opportunity to overturn *Roe v. Wade*. Such decisions on a state level violate the democracy their lawmakers swear to defend and ignore the constitution that all states in the union vow to uphold.
